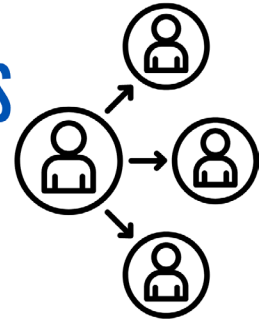

Christmas Crunch Popcorn



Ingredients

- 17 cups popped popcorn
- 12 oz Vanilla Candy Melts
- 1½ c broken pretzel pieces or mini pretzels
- 10 oz bag green and red M&Ms
- Christmas sprinkles

Instructions

Add popcorn to large bowl, remove unpopped kernels, then mix in pretzels and M&Ms. Heat Candy Melts on 50% power in a microwave safe bowl, stirring at 30 second intervals, until melted and smooth. Drizzle half of melted chips over popcorn mixture, stir to coat, then drizzle remaining over popcorn, and gently stir until evenly coated. Pour onto wax paper in a single layer and quickly add sprinkles. Allow to cool, then gently break into pieces. Store in an airtight container.

Guiding Home Buyers

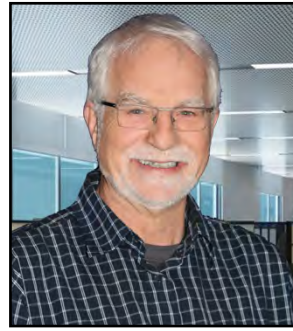

Donate Unused Decor - Once you've finished decorating you most likely have items you didn't use.
